

Client Agreement

Products and Services

Albietz Data Search shall provide the Client those services and rates specified therein. Other products and/or services requested by the Client may be provided by Albietz Data Search pursuant to this Agreement and to such additional terms and conditions as may be mutually agreed upon by the parties.

Confidentiality.

The client agrees that all reports or information requested shall be kept strictly confidential. Except as required by law, no information from reports will be revealed to the person reported on or to any other person, except a person whose duty requires him to pass on the information in relation to which the report was ordered. Client agrees to comply with the Fair Credit Reporting Act and all other applicable laws. No information will be requested for the use of any other person other than the Client's use. Requests of report information from the person reported on will be referred to the authorized Client who will provide the report information for disclosure as provided under the Fair Credit Reporting Act or other applicable laws.

Liability.

Albietz Data Search and related companies will use their best efforts to furnish Client with accurate information and to regularly maintain and augment information gathered from its customers and from selected public records. The Client understands and agrees that the accuracy of any information is not guaranteed. The Client releases and agrees to indemnify and hold harmless Albietz Data Search, its officers, agents, employees, its affiliated companies, and their affiliates from whom such reports were obtained, as well as their officers, agents, employees and independent contractors from any and all liability, including, without limitation, liability and damage from any negligence in connection with the preparation of such reports and releases Albietz Data Search from any loss or expenses suffered by the Client resulting directly or indirectly from reports or those of our affiliated companies or their affiliates from which such reports are obtained.

General Terms.

- (a) The Client shall pay to Albietz Data Search all charges incurred for pre-employment/student or internship screenings.
- (b) The Client agrees to pay all bills rendered according to the rate schedule in effect at the time services are rendered. Payment is due within ten (10) days from the date of invoice. Interest of one and one-half percent (1-1/2%) per month will be due on any past-due payments.

- (d) This Agreement may be canceled at any time by thirty (30) days written notice by either party, but such cancellation shall not terminate the Client's obligation to pay for services previously rendered. Such outstanding payables are due in full upon termination of agreement
